League Participation Agreement – Renewal (Registration NLT February 1, 2024)

This League Participation Agreement (“Agreement”) is by and between the Undersigned College or University Club Football Team (“Team”) and the National Club Football Association (“NCFA”).

The undersigned Team hereby agrees to participate in the NCFA’s 2024 season (Dates Spanning July 1, 2024 – June 30, 2025) upon the terms and conditions contained in this Agreement. The Team agrees that it will adhere to all NCFA rules and regulations, including, but not limited to, the payment of the NCFA 2024 annual dues in the amount of \$2240.00, which shall be due and payable no later than November 1, 2024. Annual dues for the 2024 season shall be discounted to \$2140.00 if paid in full by the Team on or before October 1, 2024. The Team understands that the annual dues are non-refundable. The Team further understands and agrees that all accounts or monies due to NCFA shall be paid in accordance with the Credit Terms stated above, and agrees to pay all reasonable cost of collection, in addition to any court cost and/or attorney fees incurred in collection.

The team also agrees that it will submit a \$500.00 performance bond to the NCFA prior to Sept 1, 2024. This performance bond will be returned to the team in full at the conclusion of the 2024 season provided the team has not forfeited any of its NCFA conference games. (See NCFA Rule 16.06.0)

The Team further understands that it is responsible for ensuring that all team players individually complete the online NCFA Player Registration, and agrees to submit a signed academic eligibility letter for all team players to the NCFA prior to participating in any NCFA sanctioned football games.

In consideration of the Team’s agreement to be bound by the terms of this League Participation Agreement and the NCFA rules and regulations, the NCFA hereby agrees to provide the following benefits and services to the Team throughout the term of the NCFA 2024 season:

- 1) Official recognition as a member of the National Club Football Association;
- 2) Scheduling of a regular season conference schedule of games;
- 3) Opportunity to compete for the right to participate in National Postseason play;
- 4) Full access to the Official NCFA website (www.NCFAFootball.org) for the purpose of tracking rosters, player stats, player bios, team schedules & results, conference standings, team website access, and team contact information;
- 5) Participation in the Official NCFA Fundraising Programs;
- 6) Pre-paid delivery of **12** Official NCFA game balls;
- 7) Team coverage under an NCFA general liability insurance policy;
- 8) Participation in the benefits of all Official NCFA Sponsorship programs and
- 9) Opportunity to obtain Official NCFA Consultation on club football program management issues.
